- 6. We believe that faith without works is dead and that we are created to glorify God and enjoy Him forever.
- 7. We believe that the Holy Spirit is alive and active today. He convicts us of our sin, gives us a new nature, lives within us, and guides us changing our desires and enabling us to live a godly life.
- 8. We believe in and look forward to the Lord Jesus Christ's return to earth to judge the living and the dead and to complete the eternal plan of God.
- 9. We believe that all believers are under the mandate of Jesus Christ to proclaim the Gospel to all the world.
